GLOBAL TRADE POLICY CHANGES FUEL GTC MARKET GROWTH

Global trade compliance (GTC) solutions automate and streamline processes related to customs and regulatory compliance. GTC solutions automate the discovery, creation, retention, analysis, and communication of information about international supply chains that are of importance to customs and other government authorities responsible for regulation and taxation of cross-border trade.

Geopolitically driven changes to national trade policies have increased the rate of change in tariff regulations. The volume and breadth of changes, in conjunction with the level of press coverage, have increased corporate awareness of the impact that recent, pending, and potential tariff changes can have on their business operations. In turn, there is greater emphasis

on taking the necessary steps to comply with trade regulations and minimize duty exposure. An established, formalized system such as a GTC application is seen as a valuable tool for managing the complexities, evaluating alternatives, and systematizing operational policies as they are implemented.

The GTC market is continuing its path to a higher concentration of market share in the hands of fewer suppliers due to numerous acquisitions over the last two years. Most notably, Thomson Reuters acquired Integration Point, and WiseTech Global and BluJay each recently acquired a number of smaller, regional customs and compliance providers.
